

**MINUTES OF MEETING OF CILCAIN COMMUNITY COUNCIL HELD AT THE FOOTBALL CLUB PREMISES, RHYDYMWYN ON 15 JULY 2019.**

**1. CHAIRMAN'S OPENING REMARKS**

The Chairman welcomed Members and one Cilcain resident to the July Council Meeting. Croeso i bawb i Gyngor Mis Gorffennaf.

**2. APOLOGIES FOR ABSENCE** - Cllr Janet Butlin, Cllr Pauline Douglas, Cllr Gwen Hardman, Cllr Ian Hughes,

**3 DECLARATIONS OF INTEREST** - There were no Declarations of Interest received.

**4. MINUTES OF LAST MEETING**

All Members agreed to confirm the Minutes of the meeting held at the Rhydymwyn Football Club premises on 17 June 2019 as being correct. The Minutes were signed by the Chairperson.

**5. FLOODING IN RHYDYMWYN AND HENDRE**

**Mill Terrace** - Cllr W Owen Thomas had recently spoken to several of the Mill Terrace residents. The residents had made it clear that they do not own the lane at the back of Mill Terrace. The Mill terrace residents merely have an easement to use the lane and cross the lane to gain access to land / garages at the back of the Mill Terrace.

The Clerk referred to the recent meeting with Mr Ruairi Barry at the Football Club premises on the 12 July. Mr Barry had referred to the general responsibilities of the riparian owner. However, Mr Barry had explained that if the riparian owner is identified, it is often difficult to force the riparian owner to carry out improvement work.

Cllr Gareth W Hughes reported on the position, as outlined by Mr Barry in the 12 July meeting with regard to Flintshire's proposal. A topographical survey would be undertaken and a computer model set up to assist with the design of a remedial scheme. Cllr Hughes indicated that by November, Flintshire would have a better idea regarding the nature of a remedial solution.

Cllr W Owen Thomas indicated that the width of the culvert is narrower at the outlet than at the entrance. Also, a central support can be identified at the culvert entrance.

Cllr Jean Ramsay maintained if the residents did not own the lane, they were not responsible for any repair works.

Cllr Gareth W Hughes had suggested to some of the residents that they should check their deeds to see if the landowner who gave the right of way in their deeds is identified in the deeds.

The Clerk maintained that if Flintshire was to pursue a remedial scheme they would probably have to make the necessary enquiries to establish the identity of the owner.

Cllr Thomas felt it was important for all the photographs showing the serious extent of the flooding be sent to the Assembly Member in due course. It was also important to stress the flooding at Hendre was becoming a regular occurrence.

**Lloyd's Terrace** - The Clerk reported he had now been given a contact person in Welsh Water. The comment made by the maintenance contractor regarding the need to increase the size of the pumping main was just a passing comment which did not represent the views of Welsh Water. Welsh Water were in the process of investigating if the telemetry system at the pumping station functioned effectively on this occasion. The need for venting of the rising main at Dolfechlas road to prevent smells was also discussed. Welsh Water's Engineer indicated that more emphasis is currently being placed on introducing chemicals at the pumping station sump end of the system to reduce septicity in the rising main.

Welsh Water's Engineer explained that introducing a non-return valve on a drain connection can only be effective when there is a separate foul and surface water system in place. The only known non-return valves in the Council's area are at Leete Park in Rhydymwyn, where the surface water and foul drainage discharges into a 'separate system'. Non-return valves cannot work effectively on a drain connection if both the foul and surface water discharges into a 'combined drain'.

**Fechlas Brook** - Cllr Gareth W Hughes reported that he, together with Mr Gareth Bellis and the Clerk, had recently walked the Fechlas Brook on the 9th July 2019. It had been noted that overflowing of the river bank had taken place at several locations. Photographs were tabled at the Council meeting to identify three of the problem locations. Cllr Hughes felt there was very little depth in the brook at a number of locations. The problem areas would be discussed further at a meeting to be arranged with Mr Peter Ellis from the NRW's Buckley office. The problems with the flood warning system would also need to be discussed at the NRW meeting. Clerk to arrange a Friday pm meeting.

Members concluded that once the flood water overflows the river bank, it was very difficult for the flood water to find its way back into the Dolfechlas Brook. This was presumably the reason why, following flooding incidences, the flood water is retained for several days in the fields near the Institute.

Cllr Ian Smith enquired again about the legal responsibilities of the Riparian Owner. Members referred to the guidance document 'Living on the edge' mentioned by Flintshire's Land Drainage Engineer. Clerk to obtain a copy for each Council Member, so that clarification can be obtained regarding the riparian owner's legal obligations.

**Ruby Houses** - Cllr W Owen Thomas enquired if a kerb line could be provided across the entrance of Ruby Houses to direct any water down Nant Road. Grips could also be provided on the Rhydymwyn side of Nant Road. These two suggestions had been mentioned to Mr Hickie.

Mr Hickey was proposing to jet the culvert coming down Nant Road, and also undertake a TV survey to check for the presence of obstructions or damage in this Nant Road culvert.

### **Other Highway matters raised**

- (a)p18 Star Crossing junction visibility (verge and hedge) - Cllr J Emyr Davies referred to the recent deterioration of the visibility on the Denbigh side of the Star Crossing junction. Members recalled Mr Ian Williams replacing a section of hedge with wooden rail fencing at the junction. Mr Ian Williams also arranged to have this visibility splay cut approximately every six weeks in the Summer. Clerk to pursue with Mr Hickie.
- (b)p18 Berth Road / Ffordd y Llan Junction - In the June 2019 Council Meeting, Cllr W Owen Thomas had referred to the need to consider speed control measures for vehicles approaching the junction from the Village.

Clerk to make enquiries with Mr Lee Shone in Flintshire's Traffic Section.

Cllr Thomas also referred to the need to consider a slow / araf sign on the carriageway outside Greystones in Mountain Road. Clerk to pursue with Mr Shone in Flintshire's Traffic Section.

- (c)p18 Visibility mirror at Star Crossing - Cllr J Emyr Davies referred to a visibility mirror, fixed to a BT pole, having recently been taken down. Clerk to enquire with Mr Hickie if Flintshire Streetscene had removed the visibility mirror.
- (d)p18 Visibility Splay at Fforrest Farm Junction - Item raised by Cllr J Emyr Davis in the June Council Meeting. Item to say on Agenda.

Cllr Worthington reported that the farmers union are proposing to write to Flintshire to impress upon Flintshire the need to use the Welsh Assembly's collection and testing system. Clerk to enquire regarding Flintshire's existing County wide policy on this matter.

**MATTERS ARISING - NON HIGHWAY MATTERS**

- p20 Cilcain Notice Board / Hendre Notice Board - Internal strap may be required for the Cilcain Notice Board. Item to remain on the Agenda.

With regard to the proposed Notice Board at Hendre, a decision was required regarding size, material and type of backing material preferred. In order to avoid breaking through any services, Members agreed it would be appropriate to involve Mr Hickie in any excavation in the highway verge. Mr Hickie had recently indicated that Flintshire would arrange for providing the support posts and excavating the posts in the highway verge.

Cllr Gareth W Hughes indicated he would measure again the size of the Notice Board at Llys Alyn.

Cllr Hughes and Cllr Ramsay to outline the details to the Clerk so that Mr Bateson could give a price for providing a timber Notice Board. Drawing pin system preferred to the magnet system. Traditional latch would be required.

- p20 Pedestrian Crossing, Rhydymwyn - Item to remain on the Agenda.
- p20 Town and Community Council Playscheme - Flintshire had sent the playscheme notice to the incorrect email address. However, the Clerk had posted three posters up in the village. Cllr Gwen Hardman was putting a notice up in the Shop and also on Facebook. Flintshire play leader had been to visit Cilcain school on Thursday 12 July.

Cllr Gareth Hughes reported having posted four laminated posters up in Rhydymwyn.

p20 Excavation in highway controlled land - former Post Office, Cilcain - Item to stay on Agenda.

p20 Football Club Land, Rhydymwyn - Item to stay on Agenda.

p21 Style to be repaired by gas compound - Item to stay on Agenda.

p21 A541 Overhanging hedge adjoining gas plant - Item to stay on Agenda.

p21 Village Hall lease - Cllr Ann Baker reported she had recently attended a Village Hall Management Meeting. The Hall Committee Members were keen to know when the TV survey was scheduled for. Some Hall Ctee Members were unaware of the contents of the draft lease. Hall Ctee Members would therefore welcome a meeting with the Community Council to discuss both topics. In view of the uncertainty regarding the cause of the recent surcharging drains, Council Members felt it would be more appropriate to discuss the drainage problem after the TV survey had taken place.

Regarding the proposed lease, the Chairman reported that a meeting with the Council's Solicitor had provisionally been arranged for Friday 19 July.

p20 Bryn Sholyn, Cefn Road - Item to stay on Agenda. Cllr Pauline Douglas to provide the Clerk with details of the advert regarding the dog grooming service.

p20 Bus Service, absence of time table at the Service Station bus stop. Clerk reported having written to Flintshire's Bus Service Section regarding the absence of a time table and time table holder. The time tables are currently being updated, and the updating process could take another few months.

p20 Excavation in highway controlled land - No response forthcoming from Flintshire Planning Enforcement.

p20 Coed Du Nursing Home - Cllr Gareth W Hughes reported he had not received a response from the Management. The Council would now probably have to wait until next year's meeting. Cllr Ann Baker reported she had noticed the result of a survey of Nursing Homes, where the nursing care facility at Coed Du had been upgraded.

Members expressed concern regarding the maintenance of the footpaths in the woodland area surrounding the former Trimm Rock Quarry. Clerk to write to Flintshire Footpaths Section to enquire about the status of the paths. Also, Clerk to write to Flintshire Minerals regarding the date whereby the new landowner must complete the quarry landscape restoration work.

p20 Football Club Land, Rhydymwyn - Item to stay on Agenda. Cllr Gareth W Hughes reported on his recent discussion with the Chairman of the Football Club. Cllr Hughes had requested the Football Club Chairman to respond to the Community Council letters which had been sent him. Cllr Hughes reported that the entrance gate is not currently being locked.

p21 Flintshire Forum Meeting - The Chairman reported briefly on the 25 June 2019 Forum Meeting which Cllr Ian Hughes and Cllr Gwen Hardman had recently attended.

- p21 Tree Felling Notice, Nant Alyn - Chair reported having been informed that tree felling would start in September.
- p21 Mountain Road, Cilcain - Need for Slow/Araf sign - Clerk to write to Mr Lee Shone
- - Flashing Speed Sign, Hendre - Clerk to seek an update from Mr Lee Shone.
- p21 Suspected drug use at Coed y Felin and Hendre mine shaft. Item to stay on Agenda.
- p22 Seat in Cilcain cemetery - Clerk to request Mr D May to stain the seat.
- Seat at the bottom of Cilan Lodge Road, Cilcain - Welding probably required to repair seat. Cllr J Emyr Davies to seek advice from a local welder to establish if the seat is repairable. Cost to be established.
- p24 Cemetery path, Cilcain - Cllr W Owen Thomas had asked a local engineer to prepare a brief specification for the work required. Quotations can then be obtained based on the specification obtained.
- p24 Village Hall car park - a specification is also required for a 40 sq m entrance patch and renewal of the concrete steps near the Village Hall entrance. Cllr Thomas to request a local engineer to prepare a specification.
- p25 Members recalled that Mr Derek May was no longer in a position to cut the grass around the Cilcain seats. The Chair and Vice Chair had agreed for Mr Topley to undertake the work. See details of cost in the Appendix.
- p25 Warning system for the recent 11/12 June flooding incident in Rhydymwyn and Hendre. The Failure of the warning system will need to be raised initially at the proposed meeting with the with the NRW Buckley Office Maintenance Engineer.
- p25 Cilcain Treatment Works overflow - Clerk to write to Chiara Caserotti to enquire regarding the conclusion of the Works' assessment carried out in 2016.

## **7. PLANNING MATTERS**

## **8. CORRESPONDENCE / COMMUNICATIONS**

- 1) 19/06 Petrol dirty water pumps - Information from Cllr Ian Hughes regarding prices of various sized pumps. Cllr Gareth w Hughes maintained that the option of the Council purchasing a pump or a number of pumps seemed to be a good idea at the time. However, on reflection, a number of potential problems had become apparent:
1. Choice of pump? Each flooding location would require a different type / size of pump.

2. Storage of the pump or pumps?
3. In a widespread flood situation - who decides who is to have the pump?
4. With a petrol pump, petrol deteriorates with time, requiring the petrol to be replaced on a regular basis. The pump could be on the shelf unused for five years, so regular (say every six months) checks would be required.

The Clerk maintained the worst flooding was at Mill Terrace. The considerable quantity of flood water at Mill Terrace would have required five or six large tractor driven pumps. The purchasing of such pumps in the Mill Terrace situation did not therefore appear to be a viable option.

Cllr W Owen Thomas felt the Community Council should exert its energy on persuading the appropriate Public Authorities to solve the various flooding problems. In the case of Ruby Houses, progress was being made by Flintshire Streetscene to clear the outfall ditch and clear the blocked culvert that appeared to have contributed substantially to the flood waters coming down Nant Road and into the road in front of Ruby Houses. Kerbing across the entrance to Ruby Houses also needed to be considered.

Cllr J Emyr Davies agreed that the Council should put as much pressures as possible on the Public Authorities to come up with the appropriate solutions to prevent a flooding re-occurrence. The question of regular maintenance of ditches and culverts should be pursued.

Cllr Jean Ramsay maintained - it is not just a question of supplying a pump - someone usually has to operate the pump, often standing by for hours. Cllr Ramsay referred to the Fire Service recently spending several hours assisting an elderly lady to deal with the flooding of her property at Hendre.

Cllr John Worthington referred to a small pump being used at Ruby Villas. Cllr Gareth W Hughes and Clerk explained that once the flood water had flowed into the lane in front of Ruby Villas, the flood water had nowhere to discharge to. A small two inch pump was therefore used for pumping the flood water away over a twenty hour period.

In conclusion, all Members present agreed that the purchasing of a community pump did not appear to be a practical option for dealing with the various flooding incidences which recently occurred at Hendre and Rhydymwyn.

- 2) 24/06 Flintshire Local Development Plans update - Information from Flintshire's Planning Policy Team. Position noted
- 3) 24/06 Hendre - Request for information from Cllr Jean Ramsay. Draft Council Minutes sent to Cllr Ramsay on 26 June 2019. Cllr Ramsay thanked the Clerk for the information.
- 4) 27/06 Llys Alun, play area, Rhydymwyn - details of cost of repairing boundary fence. Item discussed earlier.
- 5) 28/06 Village Hall drain - Copy of report received by Flintshire Streetscene from a member of the Village Hall Ctee regarding a potential blockage in the main drain in the vicinity of the pedestrian access gate to the memorial garden. Position noted.



- 6) 30/06 North Wales Police - crime report June 2019 - Information regarding local crime incidences from PCSO Connor Freel. Position noted.
- 7) 02/07 Flintshire Summer playscheme - Email received by Town and Community Council's regarding general information on this year's playscheme arrangement. Members noted that the email to this Council was sent to the incorrect email address. Cllr Jean Ramsay had contacted the Clerk on the 6th July to enquire if the Community Council had received information regarding this year's playscheme. Flintshire had then been contacted to make sure that the correct email address was used for all future correspondence.
- 8) 02/07 River Alun, Defra bridge catch pits - report and photos from Sando Citra regarding cleaning of the catch pits on 02 Jul 2019 by NRW. Cllr Gareth W Hughes commented that the catch pits had been cleaned out early this year.
- 9) 02/07 Visits to Town and Community Councils by Independent Members of the Standards Committee. Further feedback received from Flintshire Council regarding the recent visits. Position noted. Members discussed the option of Members having names on a card in front of each member, so that visitors to the Council meeting could identify the various Members. Cllr J Emyr Davies proposed that Members introduce themselves when visitors attend. Cllr Ian Smith seconded the proposal and all Members agreed.
- 10) 04/07 Difficulties having e-mail contact with Welsh Water regarding Lloyd's Terrace, Hendre. This problem discussed earlier.
- 11) 05/07 Collapsed drain, Star Crossing Road, Cilcain - Report received from Mrs Sue Jones - Item had been passed on to Mr Neil Hickie in Flintshire Streetscene.
- 12) 08/07 New Dispensation Form - Information from Flintshire County Council. Position noted.
- 13) 08/07 Summer Playscheme - Information from Flintshire County Council regarding the time and dates of the playscheme at Cilcain and Rhydymwyn. The posting of posters in both Cilcain and Rhydymwyn was discussed earlier.

## 9. MATTERS RAISED SINCE THE LAST COUNCIL MEETING

- (i) **Street Lamp, Dolfechlas Road, Rhydymwyn** - Cllr Gareth W Hughes had reported (21 Jun) the street lamp in Dolfechlas Road (opposite No 55/56 Llys Alun ) not working. Defect reported to Deeco Lighting. Deeco reported on 24 June that the lamp had been repaired.
- (ii) **Village Hall, Cilcain** - Drain investigation - The Chairman, Vice Chairman, County Councillor, Cllr J Emyr Davies and Cllr Gwen Hardman had met on site (21 June) to investigate the location of a suspected obstruction in the section of highway drain which crosses under the recently constructed memorial garden. Members who attended and the Clerk reported on the results of the investigation at the Council Meeting.
- (iii) **Lloyd's Terrace, Hendre** - Cllr Gareth W Hughes and the Clerk had met (24 June) three residents from the Lloyd's Terrace area regarding the recent flooding problem associated with Welsh Water's pumping station. Item discussed earlier.
- (iv) **A541, stone aggregate spill on carriageway, Tarmac exit** - On Monday 24 June stone aggregate had spilled on the A541 near the Nant Road junction. A Tarmac pick-up truck and a few men were shovelling the stone away from the carriageway when the Council Clerk was passing between 1.00 pm and 2.00 pm. In addition to the actual stone spill at the junction, a trail of single size stone was visible all along the A541

Rhydymwyn straight, and to a lesser extent on the carriageway well past the Rhosesmor junction. Fortunately, the heap of stone (approximately one barrow load) was on the lane opposite the junction, so that vehicles on the A541 approaching the bend from the Rhydymwyn direction had a reasonable view of the obstruction. Flintshire Minerals had been contacted and requested to investigate to ensure that adequate measures are in place to prevent such spills becoming a regular occurrence. The Clerk to obtain written confirmation from Flintshire Minerals that the matter had been pursued with the Quarry.

- (v) **Dolfechlas Brook, Rhydymwyn** - Cllr Gareth W Hughes, Mr Gareth Bellis and the Clerk walked parts of the Dolfechlas brook on Tuesday 9 July 2019. Several clear points of weakness in the brook system had been identified. The amount of flood water discharging down the carriageway on the Bryn Alyn bends had been discussed at the site meeting. The absence of gulleys in certain locations along this section of road was noted. Members agreed it would be appropriate to request Mr Hickie to check, with a metal detector, for the presence of gulleys covered by tarmac surfacing on this section of road.
- (vi) **Flooding, Rhydymwyn and Hendre** - A meeting had been held on Friday 12 July at the Rhydymwyn Football Club premises, for Rhydymwyn Ward Members to have the opportunity to meet Flintshire's Land Drainage Engineer. Flintshire's Land Drainage Engineer outlined the options available for promoting a grant scheme to deal with the flooding at Mill House, Felin Newydd (upper and lower Mill flat) and Mill Terrace.
- (vii) **Bus shelter, near Rhydymwyn Service Station** - Flintshire Transportation Section Emma Stephens) had been reminded of the need for a timetable and holder to be provided. Item discussed earlier.
- (viii) **Missing footpath stile, Dolfechlas Brook** - Cllr Gareth W Hughes had reported (9 July 2019) a missing stile near the footway bridge on the Dolfechlas Brook. Item had been reported to Mr J Hill in Flintshire Rights of Way Section. Clerk to seek an update from Mr Hill prior to the September Council Meeting.

10. **ANY OTHER BUSINESS** - None discussed.
